With a view to support, strengthen and improve the quality of Elementary Education in the Bodoland Territorial Council in compliance with the Right to Education Act, 2009 and in pursuance of the BTC's approval letter No. BTC/Edn(El)-91/2024-25/215, dtd. 20-06-2025, online applications are hereby invited through the official website of DE, BTC, i.e. <https://education.bodoland.gov.in> from eligible Indian Citizens as defined in Article 5 to 8 of the Constitution of India and permanent residents of Assam, who are qualified in Assam Teacher Eligibility Test (ATET)/ Central Teacher Eligibility Test (CTET) / BTC TET for filling up of vacancies of **Assistant Teacher, Science Teacher and Hindi Teacher of UP Schools** under the Director of Education, BTC, Kokrajhar in the Pay Band - 2 (PB-2) @ Rs. 14,000/- to Rs. 70,000/- plus Grade Pay and other allowances as admissible as per "The Assam Service (Revision of Pay) (Amendment) Rules, 2019".

The vacancies have been approved by the Finance (SIU) Department, Govt. of Assam. The candidates who submit online applications will be able to select district, medium of school and category of posts through the official website of Director of Education, BTC, Kokrajhar i.e. <https://education.bodoland.gov.in> using their registration. The aspiring candidates must be ready to serve in their respective places of posting in term of choice of their district.

**Conditions of Recruitment:**

1. The Director of Education, BTC, Kokrajhar reserves the right to cancel or postpone the recruitment at any state without assigning any reason thereof.
2. The candidates who have passed the ATET/CTET / BTC TET for Upper Primary School will be eligible for applying.
3. Either the Language-I or the Language-II of ATET, CTET and BTC TET candidates shall match the medium of instruction of the school where in the candidate's wishes to apply.  
As for example, if a candidate wishes to apply in an Assamese Medium School, the candidate must have Assamese as Language-I in the Assam TET/CTET/BTC TET. Likewise, for Bodo as Bodo Medium School, the candidate must have Bodo as Language-I in Assam TET / CTET/BTC TET conducted by the Elementary Education Department, Assam.
4. The Merit List will be separate for each district and category.
5. A candidate must not be less than 18 years of age and not more than 40 years for unreserved category, 42 years for Ex-Servicemen, 43 years for OBC/ MOBC and 45 years for SC/ ST(P)/ST(H) and 50 years for Persons with Disability (PwD), as on 1<sup>st</sup> January, 2025.



6. No person having more than two living children on or after 01/01/2021 from a single or multiple partners shall be eligible for appointment as per the Govt. policy on Small Family Norms, the Guidelines contained in the Notification No. ABP.69/2019/17 dated 06/11/2019 and No. ABP.69/2019/18 dated 16/11/2019.
7. The candidate shall submit the declaration at the time of online application as per the provisions contained in the Notification No. ABP.69/2019/17 dated 06/11/2019 and No. ABP.69/2019/18 dated 16/11/2019. The required declaration shall be filled up and signed by the candidates during submission of online application.
8. The eligible candidates shall apply online in the official website of Director of Education, BTC i.e. <https://education.bodoland.gov.in> from 21-06-2025 up to 10.00 P.M. of 03-07-2025.
9. No offline application will be accepted.
10. The Online Application and documents submitted by the candidate will be verified with the help of DigiLocker, Govt. of India and by scanning Barcode or QR Code for ensuring genuineness of the uploaded documents as well as by way of back-office verification with the competent board/ council/ authority. But the authority, if desires, may conduct physical document verification at any point of time.
11. The candidate must ensure genuineness of all the information/ documents uploaded against the online application and he/ she will be solely responsible for the information/documents uploaded against his/ her online application. Once uploaded there will be no scope of correction in respect of the credentials submitted by the candidates. Any discrepancy/ misrepresentation of facts/ information will lead to cancellation of the candidature.
12. The candidature will be cancelled forthwith, if any kind of fraudulence/ discrepancy/ misrepresentation of facts/ uploaded by the candidate is detected by appropriate authority at any point of time. The candidate will also be barred from taking part in any Govt. recruitment process in future and subsequent legal action will also be initiated against such candidate.
13. The regular teachers already working in UP Schools under Director of Education, BTC and DEE, Assam are not allowed to apply in same posts in UP Schools.
14. A candidate can apply only in one post in one district. **Not following this criterion will lead to cancellation of candidature forthwith.**
15. Candidate belonging to BTR shall be given preference.
16. The district wise, medium wise and category wise post details as well as date and time of received of the online application and other details will be notified in the official website <https://education.bodoland.gov.in> in due course of time.
17. The Vacancies may vary due to administrative reasons and matter under subjudice before the Hon'ble High Court.
18. The Director of Education, BTC, Kokrajhar reserves the right to make changes in the recruitment process of the publication of this advertisement.
19. There shall be reservation for PwD as per existing Government rules.
20. 3% of total posts shall be reserved for the Martyrs and Victim families of Bodoland Movement.
